

RESOLUTION NO. 2017-011

A RESOLUTION OF THE MAYOR AND MUNICIPAL COUNCIL SITTING AS THE BOARD OF CANVASSERS ACCEPTING ELECTION RETURNS AND DECLARING AND CERTIFYING THE RESULTS OF THE MUNICIPAL PRIMARY ELECTION HELD ON AUGUST 15, 2017.

WHEREAS, the Municipal Primary Election was held on August 15, 2017; and

WHEREAS, pursuant to Section 20A-4-301 et seq. of the Utah State Code, the City Council and Mayor constitute the Board of Municipal Canvassers for the City of Enterprise and do hereby canvass the returns of the Primary Election; and

WHEREAS, on August 23, 2017, the Board held a duly noticed meeting to canvass the results of the Primary Election as required by State Code.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Enterprise, Utah, acting as the Board of Municipal Canvassers for the City of Enterprise as follows:

SECTION 1: The Board hereby certifies the results as shown by the Tabulation of Election Returns as supplied by the City Recorder as shown in Exhibit "A."

SECTION 2: The Board hereby certifies that candidates: Brandon Guy Humphries and Calvin J. Barlocker had the highest number of votes and declares them nominated to proceed to the General Election.

SECTION 3: A certified report of the election results shall be prepared. Each nominated candidate shall receive a certificate of nomination. A report of the canvass will be published in a newspaper of general circulation and posted in a conspicuous place. A copy of the Canvass will be filed with the Office of Lieutenant Governor for the State of Utah, all in conformance with State Law.

SECTION 4: This Resolution shall take effect immediately upon its passage.
