Also, pursuant to section 54-4-6, Utah code annotated 1953, the City of Enterprise hereby gives notice that the Enterprise Board of Adjustment convenes on an as-needed basis in the Enterprise City Council Chambers, 375 South 200 East, Enterprise, Utah.

The City of Enterprise, in compliance with the Americans with disabilities act, provides accommodations and auxiliary communicative aids and services for all those citizens in need of assistance. Items for the Planning Commission agendas must be submitted 3 weeks in advance of the desired Planning Commission meeting, and may be moved to a later agenda at the discretion of the City.

Items for the Board of Adjustment agendas must be submitted 3 weeks in advance of the desired Board of Adjustment meeting, and may be moved to a later time at the discretion of the City.
