10-04-010 UNIFORM CRIMINAL AND TRAFFIC CODE--ADOPTED.

The state of Utah Criminal and Traffic Code, 1993, as compiled, prepared and published as a code in book form by the Utah Highway Safety Office of the Utah Department of Public Safety, three copies of which have been filed for use and examination by the public in the office of the city recorder, is approved and adopted as the criminal and traffic code for the city of Enterprise, Utah, except as such code may be altered or modified by the ordinance of this municipality. 10-04-020 DEFINITIONS.

Unless the context otherwise requires, all references in the traffic code to:

"Department of Public Safety of the State of Utah" means the resident deputy of this municipality or his agent.

"Local authorities" means the governing body of this municipality.

"Magistrate" means the justice of peace or judge of this municipality.

"State Road Commission" means this municipality and its officers, departments, agencies and agents. (Ord. 8-11-326 (part), 1985)

10-08-010 OPERATION.

Snowmobiles cannot operate on any city street, or street right-of-way, except: they are permitted to cross the street at right angles, when necessary to reach a predetermined, designated snowmobiling area, but must come to a complete stop before entering the street, also they must yield right-of-way to any traffic. Snowmobiles may be operated on the extreme right-hand side of the street right-of-way, when traveling to a predetermined, designated area. Snowmobiles must be operated by a licensed driver at all times when in use on any public domain. (Ord. 88-7 (part), 1988: Ord. dated 4/12/79 (part))

10-08-020 VIOLATION--PENALTY.

Any person who violates any of the provisions of this chapter, where the penalty is not otherwise provided for, shall be guilty of a misdemeanor and upon conviction thereof shall be punished by a fine in any sum less than one thousand dollars, or by imprisonment in the city jail not exceeding six months or by both such fine and imprisonment. OFF-HIGHWAY VEHICLES**

10-10-010 OPERATION AND SUPERVISION

A person may not operate and an owner may not give that person permission to operate an off-highway vehicle on any public land, trail, street, or highway of this City unless the person:

- a. is under the direct supervision of a certified off-highway vehicle safety instructor during a scheduled safety training course;
- b. (i) has in the person's possession the appropriate safety certificate issued or approved by the division; and
(ii) if under 18 years of age, is under the direct supervision of a person who is at least 18 years of age if operating on a public highway that is:
 - (A) open to motor vehicles; and
 - (B) not exclusively reserved for off-highway vehicle use; or
- c. has in the person's immediate possession a valid motor vehicle operator's license, as provided in Title 53, Chapter 3, Uniform Driver License Act.

10-10-020 REGISTRATION

All OHV's are required to be registered with the Department of Motor Vehicles and have the proper stickers displayed. If the vehicle is used for animal husbandry and exclusive off-highway use, this must be declared at the time of registration.

10-10-030 DESIGNATED ROUTES AND ROADS

The operator of a OHV may, with valid certification as defined in 10-10-010, drive on city streets within city limits, except Main Street and SR-18, for the purpose of going from one place to another. Main Street and SR-18, as state roads, may only be crossed to get to other city streets.

10-10-040 SPEED AND OTHER REGULATIONS

- a. Off-highway vehicles shall be operated at all times in accordance with all applicable laws and regulations and shall not be operated at speeds in excess of twenty-five (25) miles per hour on Enterprise City streets.
- b. No off-highway vehicles shall be allowed on any Enterprise City street between the hours of 10:00 p.m. and 5:00 a.m.
- c. All operators and passengers under 18 years of age shall wear helmets.
- d. Every operator and passenger must have an approved seat.

AUTHORIZED MOTOR VEHICLES**

10-12-010 LIMITING ACCESS BY MOTOR DRIVEN VEHICLES.

It is unlawful for any unauthorized motor driven vehicle to enter the private access road to the city water tanks on 400 West. (Ord. 97-03-01 §1)

10-12-020 BOUNDARIES.

The boundaries of said limited access shall be as follows: Beginning at the end of the asphalt pavement on 400 West and approximately 150 South, at the point of the city street sign indicating the access limitations, then continuing south to the end of the unimproved dirt road. (Ord. 97-03-01 §2)

10-12-030 EXCEPTIONS.

This chapter shall not apply to the city, Washington County, state or federal government emergency response or staff vehicles using the road for emergency response or during the normal course of their designated duties. In addition, this chapter shall not apply to those private property owners directly fronting or accessing their private properties in the normal course of their duties. (Ord. 97-03-01 §3)

10-12-040 VIOLATION--PENALTY.

Violation of this chapter shall constitute a Class B misdemeanor and shall be punishable by a fine not to exceed one thousand dollars or by imprisonment on the city or county jail for a period not to exceed six months, or by both such fine and imprisonment. (Ord. 97-03-01 §4)
