**CONDITIONS OF SERVICE: I hereby understand and agree to the following:**

**NEW SERVICE:** All utility bills are due and payable on or before the 15<sup>th</sup> day of each month as stated on the bill. If the utility bill is not paid within 45 days of the billing date, the service will be discontinued and will not be reinstated until all fees, penalties and delinquencies are *paid in full*. A ten dollar (\$10.00) per utility fee will be assessed to any account that is terminated due to delinquency. I also understand that all delinquent accounts will be charged interest at 2% per month. The undersigned specifically agrees to pay all reasonable attorneys' fees and court costs in the event legal action is taken to collect on an account. The undersigned further agrees to pay an additional amount representing up to 40% of the principal balance if the account is referred to a collection agency or attorney for collections. This additional amount is in recognition of the cost associated with said collection action processing.

**SECURITY DEPOSIT:** I understand that I am required to pay a security deposit if I am not the owner of the property served. I understand that the deposit is not considered as a prepayment of any bill. Unpaid accounts will be considered delinquent not withstanding the existence of a security deposit. The City may apply the amount of the security deposit to my final bill and any balance remaining will be refunded to me.

**RE-CONNECT:** I understand that all reconnected services are under the same conditions as a new service. All re-connected utilities will be charged a tiered reconnect fee dependent on the amount of time the service has been disconnected. The reconnect fee for up to 12 months of disconnected service is fifty dollars (\$50.00) per utility, from 13-36 months is seventy five dollars (\$75.00) per utility and 37 months and longer is one hundred dollars (\$100.00) per utility. Service utility transfers where there is **no interruption in utility services** will be charged a ten dollar (\$10.00) connection fee per utility.

**DISCONNECT:** I, the undersigned, wish to permanently disconnect utility services at the above address and am responsible for the immediate payment in full of all utility charges incurred at these premises. If a utility deposit has been collected, the deposit will first be credited to the final bill. I also understand that if services are left disconnected for an extended period of time and are unable to be used, cost to replace services will be done at the property owners expense.
