# Chapter 9-04 CRIMINAL CODE

#### Sections:

9-04-010 Statutes adopted.

#### 9-04-010 STATUTES ADOPTED.

- A. Municipal Criminal Ordinance Code. The Municipal Criminal Ordinance Code published by the Utah League of Cities and Towns and printed as a code in book form, three copies of which have been filed with the recorder for use and examination by the public, is adopted.
- B. Code to be construed as Continuation. So far as the provisions of the Municipal Criminal Ordinance Code are the same or similar to those of the ordinances repealed by the ordinance codified in this chapter, they shall be construed as continuations thereof. (Ord. 1-115 §§1, 2, 1983)

#### 9-06-010 CURFEW.

It is unlawful for any person under the age of eighteen years of age, to be on or remain upon any of the streets, alleys, public places or vacant lots at night between the hours of ten-thirty p.m. and six a.m., the following day, Sunday through Thursday, and eleven-thirty p.m. and six a.m. the following day, Friday and Saturday, unless such person is accompanied by a parent, legal guardian or other person having legal custody of such minor person. (Ord. 9.06.002 §1, 1994)

#### 9-06-020 **EXCEPTIONS.**

This chapter shall not apply to those individuals under the age of eighteen years of age who are accompanied by, or in the custody of a parent, legal guardian or other legal custodian. On any night when school, civic, or church approved functions are taking place, the hours of curfew shall extend to allow adequate time for those going to or departing from such approved function to comply with this chapter and times specified. Furthermore, in the event employment or lawful business activity of such minor makes it necessary to be upon the streets, alleys or public places between such specified hours, it shall be the full responsibility of said minor and parent or legal guardian to provide upon demand from local authority, proof of such employment or lawful business activity. (Ord. 9.06.002 §2, 1994)

## 9-06-030 RESPONSIBILITY OF PARENT, GUARDIANS FOR CURFEW.

No person, legal guardian, or other legal custodian of any person under eighteen years of age shall allow or permit such person or child, ward or other person under such age, while in such legal custody, to go or be in or upon any of the streets, alleys, public places or vacant lots, when such going or being in or upon such streets, alleys, public places or vacant lots would be a violation by said minor person of any provisions of Section 9-06-010 and 9-06-020. (Ord. 9.06.002 §3, 1994)

#### 9-06-040 VIOLATION--PENALTY.

Violation of this chapter shall constitute an infraction and shall be punishable up to the full extent of the law. (Ord. 9.06.002 §4, 1994) (Ord. 2002-03, 2002)

### 9-08-10 **DEFINITIONS**:

The term "firearm" is defined to mean any rim fire or center fire cartridge pistol, revolver, rifle, shotgun, gun or similar device. (Paint ball guns, air soft guns, toy guns and similar devices, so long as they are not being fired to cause harm or damage, but are being used as designed for mere recreation, are not covered under this section and this definition). (Ord. 2010-03, 2010)

#### 9-08-20 UNLAWFUL TO DISCHARGE FIREARMS:

It is unlawful for any person to discharge a firearm within the city limits of Enterprise, Utah unless such discharge of a firearm strictly conforms to the exceptions listed below. (Ord. 2010-03, 2010)

### 9-08-30 **EXCEPTIONS**:

- A. Law Enforcement personnel within the course of their duty
- B. City Personnel within the course of their duty
- C. Governmental Wildlife Officials within the course of their duty

- D. Depredation Hunters specifically permitted by state wildlife officials to carry out a prescribed action within the city.
- E. Defense of human life and property
- F. An area within the City Limits that is more than 1000 feet from a paved road or residential dwelling

## 9-08-40 RESTRICTIONS AND LIMITATIONS:

The City Council may place restrictions and limitations on firearms use within this area that may go beyond the general hunting regulations put forth by the state. (Ord. 2010-03, 2010)
